### ANTIGUA AND BARBUDA

#### No. 2 of 2001

**AN ACT** to authorise the Minister of Finance to borrow the sum of Five Hundred Thousand United States dollars or the equivalent in Eastern Caribbean Currency to settle the arrears of salary increases to teachers.

[ 19th April, 2001 ]

**ENACTED** by the Parliament of Antigua and Barbuda **as** follows —

**1.** This Act may be cited as the **Westbond** International Bank Limited (Loan) Act 2001.

**2.** (1) Notwithstandingthe provisions of any Act, the Minister is authorised to borrow the sum of Five Hundred Thousand United States dollars or its equivalent in Eastern Caribbean currency on terms and conditions agreed between the Minister and **Westbond** International Bank Limited.

- (2) The **sum** of money borrowed by the Minister **pursuant** to subsection (1) shall be paid into and shall form part of the Consolidated Fund.

**priated** and applied to finance the payment of the salary increases agreed with the Antigua and Barbuda Union of Teachers and approved by Cabinet.

Power to issue instruments.

4. The Minister may issue such promissory notes or other instruments as may be necessary for the purpose of giving effect to the terms of any agreement entered into by him with the lender in respect of the sum of money borrowed under this Act.

Principal and interest to **be** charged on the Consolidated Fund.

5. The principal sum of money borrowed under the authority of this Act and interest on that sum are charged on and payable out of the Consolidated Fund.

Ratification of agreements.

6. The Cabinet Decision approving the borrowing of the loan and the agreement with **Westbond** International Bank Limited specified in the Schedule are ratified.
