WHEREAS there has been constituted a Conference known as the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church consisting of the churches in Antigua and Barbuda, St. Thomas, St. Croix, St John, Barbados, St. Christopher and Nevis and Trinidad and Tobago, which have been officially organised and accepted into fellowship by votes of the delegates assembled in session.

AND WHEREAS it is desirable and expedient that the said Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church shall have the right to acquire, hold, deal with and dispose of moveable and

immoveable property in Antigua and Barbuda for the purposes of the said Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church.

Short title.

1. This Act may be cited as the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church (Incorporation) Act.

Incorporation.

2. The Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church is hereby constituted a body corporate under the name and title of "The Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church" with perpetual succession and a Common Seal and with power and authority by that name to sue and be sued, to acquire and to hold real and personal property for all purposes connected with the administration of the affairs of the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church in Antigua and Barbuda and with power to sell, mortgage, alienate, lease, exchange or otherwise dispose of the said property.

Execution and subscription of deeds etc. by Chairman.

3. All deeds of conveyance or reconveyance, mortgages, charges, leases, transfers, contracts, assignments or other deeds and documents whatsoever and all powers of attorney and all notarial instruments required to be executed by the said Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church shall be deemed sufficiently executed if sealed with its common seal and subscribed by the Chairman or Vice Chairman of the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church for the time being and such execution shall be valid and effectual at law.

Vesting of property.

4. All real and personal property in Antigua and Barbuda now held by or vested in any person on behalf of the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church in Antigua and Barbuda are hereby transferred to and vested in the Provincial Elders' Conference of the Eastern West Indies Province of the Moravian Church and its successors for the same estates and interests and to the extent to which the same were respectively at the time of the passing of this Act held or vested

as aforesaid, subject to the rights reservations and charges if any, now affecting the same and the trusts upon which the same are now held.

5. Nothing herein contained shall affect or be deemed to affect the rights of Her Majesty, Her heirs and successors or any body politic or corporate or of any other persons except such as are mentioned in this Act and those claiming by, from or under them. **Saving of Crown and other rights.**
