#### PART I

# **Preliminary**

**1.** This Act may be cited as the Barbuda Act.

Short title.

Application.

2. All Acts of Antigua and Barbuda, together with all rules, regulations, by-laws and other instruments thereunder made shall, with respect to the Island of Barbuda, be repealed in so far, but so far only, as the provisions of the same are repugnant to the provisions of this Act and to any by-laws or other instruments made hereunder or any Act amending the same in the same manner as if such Acts, rules, regulations, by-laws and other instruments had been specifically and particularly mentioned and set forth.

# 3. In this Act—

Interpreta-

- "allotment" means village allotment or house-site;
- "boarding officer" means any person authorised under section 51 to board and search a boat;
- "boat" means every description of craft whether registered or not;
- "coasting trade" means all trade by sea between the islands of Barbuda and Antigua;
- "the Council" means the Barbuda Council established under the provisions of section 3 of the Barbuda Local Government Act:

"dog" includes a dog or bitch of any age whatsoever;

- "enclosure" includes those places and areas within the island of Barbuda known as the Meadow and the Guava, and any place or area which the Council shall at any time declare by by-law to be an enclosure:
- "game" includes wild pig, ducks, widgeon, pigeons, doves, guinea fowl, pheasants, partridges and hares, and any bird or beast which the Council may from time to time by by-law declare to be game;
- "gun" includes cannon, revolver, pistol, air gun and every other kind or description of arm from which a missile can be discharged;
- "horse" includes stallion, mare or gelding;
- "livestock" includes horses, mules, asses, sheep, lambs, cows, oxen, bulls, calves, heifers, steers, goats, kids and pigs, and any animals which the Council may from time to time by-law declare to be livestock;
- "master" includes every person having or taking charge or command of any boat;
- "the Secretary" means the Secretary of the Council appointed under the Barbuda Local Government Act;
- "timber" means every kind of growing tree except brushwood;
- "the village" means that portion of the Island of Barbuda bounded as follows—

On the North by a wall separating it from Sedge Garden.

On the South by a line commencing at the southern extremity of the eastern boundary and running parallel to the south wall of the old village until it reaches the lagoon.

On the East by a wall separating it from Indigo Piece and by a line commencing at the southern extremity of the said wall and continued in a southerly direction for 700 yards.

On the West by the lagoon.

### PART II

Tenure of Lands by Inhabitants of the Island

**4.** All lands within the Island of Barbuda are hereby vested in the Governor-General on behalf of the Crown and Covernor-General on behalf of the shall be dealt with in accordance with the provisions of this Crown. Act.

5. (1) All persons inhabiting the Island of Barbuda Inhabitants are shall be and are hereby declared to be tenants of the Crown; Crown. and such persons shall neither hold nor deal with any land situate within the said island save and except as hereinafter appears by the provisions of this Act and subject to any bylaw made by the Council in that behalf.

- (2) Nothing in this section shall be construed as precluding the grant by the Crown of any interest in or over any piece or parcel of land within Barbuda to any person whether or not that person is an inhabitant of Barbuda.
- (3) Notwithstanding the provisions of any other law, no person shall acquire the ownership of any piece or parcel of Crown land within Barbuda by prescription.
- (4) If any inhabitant of Barbuda can show to the satisfaction of the Crown that a grant by the Crown to any other person of any interest in or over any piece or parcel of land within Barbuda has caused him any material loss in respect of any use that he has been making of that piece or parcel of land by virtue of the provisions of subsection (1) of this section, that inhabitant shall be entitled to fair compensation in respect of that loss within a reasonable time.
- (5) An inhabitant of Barbuda to whom subsection (4) of this section applies shall have the right of access to a tribunal appointed by the Chief Justice to determine the amount of any compensation to which that inhabitant is entitled under this section and for the purpose of obtaining payment of that compensation.
- (6) A tribunal appointed under subsection (5) of this section shall consist of a chairman who shall be a barrister or solicitor of not less than five years standing and two other members being persons appearing to the Chief Justice to

be qualified for appointment by virtue of their knowledge of and experience in Barbuda affairs.

- (7)An appeal shall lie to the High Court from any decision of a tribunal appointed under subsection (5) of this section; such appeal shall be exercisable as of right at the instance of any party to the proceedings before the tribunal and shall be final and conclusive for all intents and purposes whatsoever.
- (8) The Chief Justice may make rules with respect to the practice and procedure of the High Court and a tribunal in relation to the jurisdiction conferred upon the High Court by this section or exercisable by a tribunal for the purposes of this section (including rules with respect to the time within which applications to the High Court or a tribunal may be brought).

### PART III

# Allotments, Buildings and Provision Grounds

Allotments in village.

- **6.** It shall be lawful for the Council, with the sanction and approval of the Cabinet, to allot, distribute and divide all land within the village amongst villagers subject to the following conditions—
  - (a) The lands shall be laid out in allotments of such dimensions and areas as the Council shall direct.
  - (b) Every such allotments shall be used exclusively by the allottee thereof for the purpose of erecting and maintaining a house or hut thereon as a place of residence.
  - (c) The allottee or tenant shall pay as rent in respect of land allotted to him such sum as the Council may from time to time see fit to impose, and until some other rent be imposed a rent of twenty-four cents per annum, commencing from the date of such allotment, shall be paid by such allottee or tenant.
  - (d) In all cases where any rent in respect of such allotment shall remain unpaid after the same shall have become due and payable, the Secretary shall serve the tenant thereof with a notice to quit, and where such

tenant shall either refuse or neglect to quit such allotment, the Secretary may take all such proceedings as are prescribed by the Small Tenements Act for the pur- Cap. 406. pose of ejecting him therefrom.

7. It shall be lawful for the Council, with the sanc- Reservation for tion and approval of the Cabinet to set apart for public purposes all such portions, either within or without the confines of the village, as may be deemed expedient and to lay out the same as to the Council with the concurrence of the Cabinet shall appear best adapted for improving the Island of Barbuda and promoting the health, comfort and security of the inhabitants, reserving such portions for highways, paths or otherwise as shall appear desirable.

public purposes.

8. It shall be lawful for the Council with the sanction Highways. and approval of the Cabinet to stop up and divert any highway or path within the Island, whether in the village or not, and to open up and make other highways and paths through the said Island.

(1) It shall be lawful for the Council with the sanc- Allotment and tion and approval of the Cabinet to set apart such portions rental of provision of land, without the confines of the village, as may be deem- grounds. ed expedient for the purpose of such lands being used and cultivated by the villagers as provision grounds.

- (2) All such lands as aforesaid when so set apart for such purposes as aforesaid may be allotted and divided amongst the villagers in such plots as the Council shall deem expedient.
- (3) The rent payable in respect of every such plot as aforesaid shall be at such rate per acre as the Council may from time to time see fit to impose and until some other rate be so imposed the rent shall be at the rate of twentyfour cents per acre per annum payable from the date of allotment.
- 10. In all cases where any rent in respect of any such provision ground shall remain unpaid after the same shall rent. have become due and payable, the Secretary shall serve the tenant thereof with a notice to quit and where such tenant shall either refuse or neglect to quit such provision ground

the Secretary may take all such proceedings as are prescribed by the Small Tenements Act for the purpose of ejecting him therefrom.

Cutting timber and burning charcoal.

11. No person shall cut or fell any growing timber nor burn any charcoal within the Island of Barbuda, unless such person shall first have obtained from the Council a permit in writing for such purpose; and any person who shall cut or fell any growing timber or burn any charcoal save and except under the sanction of a permit first had and obtained from the Council as aforesaid shall be guilty of an offence against the provisions of this Act and shall be liable on conviction thereof to a penalty not exceeding three thousand dollars.

### PART IV

# Regulations with Respect to Deer and Other Game

Permit to shoot deer.

12. No person shall shoot any deer or game within the Island of Barbuda unless he shall have first obtained a permit from the Council or some other person appointed by the Council for such purpose as hereinafter provided.

Close time for deer.

13. There shall be a close time for all deer within the Island of Barbuda, such close time being the months of April, May, June, October, November and December in every year, or any other period which the Council may by order published in the *Gazette* determine:

Provided always that in the months of January, February and March no does shall be shot.

Deer not to be shot during close time, except in enclosures. **14.** During such close time aforesaid it shall not be lawful for any person to shoot or destroy any deer within the said Island and any person who shall shoot or destroy any deer during such close time as aforesaid shall be guilty of an offence against the provisions of this Act and shall be liable on conviction thereof to a penalty not exceeding three thousand dollars:

Provided always that within enclosures set apart for agricultural purposes by order of the Council all deer may be shot at any time by any person specially authorised by the Council.

15. It shall be lawful for the Council to issue permits Permit to shoot in all cases where it is deemed expedient so to do, to such deer or other game on persons as may be desirous of shooting deer or other game; payment. and every person to whom such permit shall be issued shall pay to the Council in respect thereof such sum as may be prescribed by by-law:

Provided that for every deer shot under the said permit after the number of three the sum of ninety-six cents shall be paid; and every person to whom a permit is issued shall deposit with the Secretary at the time of issue a sum sufficient to cover the total amount payable in respect of the total number of deer named in the permit:

Provided also that in no case shall a permit to shoot deer be issued during the close time aforesaid, except in the enclosures aforesaid; and provided further that the maximum number of deer to be shot within the Island of Barbuda within any year shall not exceed such number as the Council shall hereafter determine.

**16.** Every such permit as aforesaid shall be in the form and contain all such particulars therein appearing, and set forth in Schedule C and in all cases where any person to whom any such permit shall have been issued shall contravene in any manner whatsoever any of the provisions of this Act in respect thereof it shall be lawful for the Council to cancel and revoke such permit.

# PART V

# General Regulations with Respect to Taxes and the Collection and Payment thereof

17. There shall be levied, collected and paid Taxes. throughout the Island of Barbuda such sums by way of taxes on dogs, boats and livestock as the Council may from time to time fix and determine:

Provided that until otherwise determined, there shall be levied, collected and paid throughout the said Island by way of taxes, the sums set out in Schedule A for a licence Schedule A. to keep a dog, a licence to keep a boat, and a licence to keep livestock.

### Barbuda

Licences granted by Council.

18. Any person desiring to obtain a licence with respect to any of the matters and things set forth in Schedule A or with respect to any animal declared by by-law to be livestock shall apply to the Council for the particular licence required and the Council shall on payment by such applicant of the sum payable in respect of the particular licence applied for, grant such licence in such form as set forth in Schedule B as the nature of the licence requires:

Schedule B.

Provided that the Council may refused to grant a licence to keep a dog.

Licence to be numbered.

19. Every licence granted under and by virtue of the provisions of this Act shall be duly numbered and shall bear the date and commence on such day as the same shall be granted and shall expire on the 31st day of December in each year.

Register of licences.

- **20.** The Secretary shall keep a register of all such licences granted under the provisions of this Act setting forth—
  - (a) the particular kind of licence granted,
  - (b) description and size as the case may be of the animal or thing in respect of which the licence is granted,
  - (c) the name, occupation and place of abode of the person to whom the licence has been granted.

Licences to be produced for inspection.

21. The holder of any of the various licences granted under the provisions of this Act shall produce such licence for inspection whenever required to do so by the Magistrate or the Council or any person duly authorised by the Council in that behalf, and any holder of such licence as aforesaid who shall fail to produce the same when required so to do for every such failure to produce such licence shall be liable on conviction to a penalty not exceeding one hundred dollars.

Importation and exportation of livestock.

**22.** (1) No person shall import into or export from the said Island of Barbuda any livestock without having first obtained a permit in that behalf in writing from the Council.

- (2) The granting or refusal of such permit shall be in the discretion of the Council, and the Council may either grant or refuse the same without assigning any reason and its decision shall be final.
- (3) Any person who contravenes subsection (1) shall be liable on summary conviction before a Magistrate to a penalty not exceeding one thousand dollars, and any such animal so imported or exported in contravention of the said subsection shall be forfeited and may be dealt with in any manner the Council shall deem fit.
- (4) All permits granted under and by virtue of this section shall remain in force for fourteen days after the date of the granting thereof and shall thereafter be absolutely void.
- (5) The master of any boat who takes on board, or permits to be taken on board, his boat any livestock in respect of which no permit has been granted, and the person exporting or attempting to export the same shall be liable on summary conviction to a fine not exceeding five hundred dollars, and such boat shall be forfeited to the Crown and may be seized by the Secretary or by any member of the Police Force if found within two years from the commission of the offence in any port or place in the Island of Barbuda or the Island of Antigua and when seized may be dealt with in accordance with the provisions of section 47.
- No person shall keep a dog during any year or Dog Licences. any portion of a year whether such dog be his own property or not, without having first obtained a permit and licence in respect thereof as hereinbefore provided; and any person keeping a dog or dogs without having first obtained such permit and licence shall be liable on conviction to a penalty not exceeding two hundred and fifty dollars in addition to the cost of the licence.

(1) The Secretary shall deliver to every person Metal badges. 24. to whom a dog licence shall have been granted under the provisions of this Act a metal badge of such design and bearing such marks for the purposes of identification as shall be approved by the Council.

- (2) Every holder of a dog licence granted under the provisions of this Act shall cause to be affixed round the neck of the dog in respect of which such licence has been obtained such metal badge with which he has been furnished, and every such dog shall wear such metal badge during the subsistency of such licence.
- (3) At the expiration of any dog licence, the holder thereof to whom such metal badge as aforesaid shall have been supplied by reason of his taking out the same, shall forthwith deliver such badge to the Secretary and every person contravening the provisions of this section by making default in the prompt delivery of any badge upon the expiration of the licence in respect of which the same was issued shall, on conviction, be liable to a penalty not exceeding fifteen dollars.
- (4) Any person using a counterfeit or invalid badge shall be liable on conviction to a penalty not exceeding two hundred and fifty dollars.

Dogs without badges may be destroyed.

**25.** It shall be lawful for the Secretary or any person acting under his orders and instructions to seize or destroy any dog found at large within the Island of Barbuda not wearing the metal badge round its neck as heretofore provided.

Ownership of dog.

**26.** Every person in whose custody, charge, or possession any dog shall be found or seen shall for the purposes of this Act be deemed to keep such dog unless the contrary be proved.

Boat licences Schedule B. 27. No person shall possess or own any boat within the Island of Barbuda without having first obtained a licence in respect thereof as hereinbefore provided; and any person who shall possess or own any boat without having first obtained such licence as aforesaid shall be liable on conviction to a penalty not exceeding one thousand dollars, in addition to the amount payable in respect of a boat licence.

Boat licences may be cancelled for smuggling. **28.** In all cases where the holder of any boat licence is convicted of smuggling or of contravening in any manner whatsoever any of the Trade and Revenue Laws of Antigua and Barbuda, it shall be lawful for the Council to revoke the boat licence granted to such person and to seize such

boat and to deal with it in accordance with the provisions of section 47.

It shall be lawful for the Council or any person Unlicensed boat duly authorised by the Council to seize any boat in respect of which the owner has failed to take out a licence; and every boat so seized as aforesaid shall be dealt with as the Council may direct.

**30.** The owner of every boat shall cause to be painted Name and upon the bows and stern thereof the name of such boat number of boat. together with the name of the owner; and in all cases where such boat carries sail the owner shall cause to be painted on the mainsail thereof, in such manner as the Council may direct, the letter B, together with a serial number to be allotted to such boat by the Council on licensing the same.

31. No person shall own any livestock within the Livestock Island of Barbuda without having first obtained a livestock licence in respect thereof as hereinbefore provided, and any person who shall possess or own any livestock without having first obtained such licence as aforesaid shall be liable on conviction to a penalty not exceeding one hundred dollars, in addition to the amount payable in respect of such livestock licence.

licences.

32. Every person in whose custody, charge or posses- Avenus person in whose custody, charge or possession any livestock shall be found or seen shall, for the purposes of this Act, be deemed to be the owner of such livestock unless the contrary be proved.

The owner of any livestock licensed as aforesaid Livestock to be (pigs excepted) shall keep such livestock within the prescribed limits of that portion of the Island which the Council shall from time to time assign to the villagers for grazing purposes; and any livestock found outside such prescribed limits without the Council's permission shall be liable to be seized by the Secretary or any person acting under his orders or instructions and when seized may be dealt with in accordance with the provisions of section 47.

All pigs shall be kept at such places outside of Pigs outside the village as the Council shall from time to time prescribed limits to be destroyed. for that purpose, and any pig found outside of such prescribed

limits shall be shot or destroyed by the Secretary on the authority of the Council.

Unlicensed stock may be seized.

**35.** Any livestock in the Island of Barbuda, in respect of which a stock licence is necessary under the provisions of this Act and in respect of which no such licence shall have been taken out and is in current force, shall become and be the property of the Council and shall be dealt with by the Secretary in all respects as if such livestock had originally been the property of the Council;

Provided that it shall be lawful for the Council on the application of the owner of such livestock on good cause shewn to order such livestock to be returned to the owner, subject to such terms and conditions as to the Council may seem fit.

Licensed animals to be marked.

**36.** It shall be lawful for the Council to cause the holders of a livestock licence to mark the animals comprising such livestock licence in such manner as the Council may from time to time direct for the purposes of identification in order that the provisions of this Act may be the better carried out; and in all cases where the holder of any livestock licence fails to mark his livestock at the time when and in such manner as the Council directs he shall be liable on conviction for every such failure to a penalty not exceeding one hundred dollars, and all such stock which may be found without the prescribed marks upon them may be seized and dealt with in accordance with the provisions of section 47.

#### PART VI

# Highways and Enclosures, and Sanitary Regulations

Repair of roads, wells, etc.

37. It shall be the duty of the Secretary to supervise the repairs of the highways, wells and enclosures of the Island of Barbuda and for that purpose to employ and pay labourers to prevent any encroachments on and injuries to the same and generally to carry out and enforce the provisions of this Act and any by-law made by the Council and to prosecute all persons offending against the same.

Sanitary regulations.

38. The Council may in order to ensure the cleanliness of, and to secure the sanitation of the village and to promote the health of, and prevent the spread of any epi-

demic, infectious or contagious disease amongst the inhabitants of the Island of Barbuda make any by-law with respect to the following matters-

- (a) the drainage of all buildings within the Island and more particularly with respect to earth closets, privies and cesspools used in connection therewith.
- (b) the closing and shutting up of all buildings or parts of buildings of any kind whatsoever unfit for human habitation and the prohibition of their use.
- (c) all tanks and wells used in connection with any building or otherwise for the purpose of ensuring wholesale storage of water,

and may attach to any breach of any such by-law a penalty which may extend to five hundred dollars, and in the case of a continuing offence, a further penalty which may extend to twenty-five dollars for each day after written notice of the offence.

39. It shall be the duty of the Secretary to ensure that Removal of filth. all rubbish, excrement and filth of any description be duly removed from any highway or path within the village.

It shall be lawful for the Secretary at all reawnable hours in the daytime, with a view to ascertaining the sanitary condition thereof, to enter into, visit and inspect all buildings and enclosures and premises attached thereto within the Island of Barbuda.

Sanitary inspection.

41. The occupier of every allotment shall keep the Allotments to be same clean and clear of growing bush, rubbish, excrement and filth of any description, and keep all walls and fences appertaining thereto in good and effective repair to the satisfaction of the Secretary, and in default thereof it shall be lawful for the Secretary to give notice to such occupier requiring him within reasonable time to cleanse the same and every such occupier who shall fail to comply with such notice shall be liable to a penalty not exceeding five dollars for every day during which he shall fail to comply with such notice.

#### Barbuda

### PART VII

Regulations with Respect to Coasting Trade

Coasting licence.

Schedule D.

- **42.** (1) No boat shall engage in any coasting trade unless the master thereof shall have first obtained from the Council a licence in the form set forth in Schedule D for that purpose; such aforesaid licence shall remain in force for the space of twelve months from the date of issue.
- (2) The licence, for which the sum of one dollar and twenty cents is payable, shall remain in force for the space of twelve months from the date of issue.

Master of licensed boat to keep pass book.

43. The master of every boat so licensed to engage in coasting trade as aforesaid shall keep a pass book in which a legible entry shall be made by him of all cargo intended to be shipped and carried together with the destination of such boat.

Pass book to be signed as clearance.

44. Before proceeding coastwise the master shall produce such pass book to the Secretary in order that he may sign the same and grant a sufferance for the departure of such boat. All boats shall proceed direct to St. John's, where such pass book shall be produced to the Custom Office before going elsewhere. The master of such boat shall further cause to be entered in the said pass book all cargo intended to be carried to Barbuda, and shall obtain the signature of a Treasury officer to the same before departure from Antigua, and shall on return to Barbuda, produce such book to the Secretary.

Master of boat failing to comply with provisions of Act liable to penalty. 45. In all cases where the master of any boat licensed to be engaged in coasting trade shall fail or neglect in any respect whatsoever to comply with the provisions of this Act such master shall on conviction be liable to a penalty not exceeding three thousand dollars.

#### PART VIII

#### Miscellaneous

Recovery of fine and penalties.

**46.** All fines and penalties imposed under and by virtue of the provisions of this Act shall be recoverable summarily before a Magistrate under the provisions of the Magistrate's Code of Procedure Act, and proceedings for

the recovery of any such penalty may be commenced at any time within two years after the commission of the offence by reason whereof such penalty has been incurred.

47. All animals and things forfeited or liable to Animals and forfeiture or seized under or by virtue of the provisions of to be sold. this Act shall unless some other procedure be prescribed by this Act be delivered to the Secretary, who shall cause the same to be sold by public auction within or without the Island of Barbuda, or shall otherwise dispose of the same in such manner as the Council may direct:

Provided always that is shall be lawful for the Council on the application of the owner of the animal or thing so seized as aforesaid to order the same to be returned to him subject to such terms and conditions as the Council may seem fit.

48. Every person who assaults, obstructs, or hinders Penalty for in any way whatsoever or uses any abusive or offensive abusing officer or language to any officer, servant, or other person who shall servant. be engaged in lawfully carrying out and executing any of the provisions of this Act or any by-law framed hereunder shall be guilty of an offence and shall be liable on conviction to a penalty not exceeding five hundred dollars.

49. All moneys paid to the Secretary or any person Maneys are childed duly authorised by him to receive the same accruing due separate fund. and payable from any source whatsoever under and by virtue of the provisions of this Act or arising on the sale of any stock or property in the Island of Barbuda belonging to the Council shall be lodged by the Secretary in a deposit account at a bank approved by the Cabinet. All expenses incurred under this Act or otherwise for the service of Barbuda shall be provided for in the estimates of Antigua and Barbuda.

Any person who does anything forbidden to be Penalties where done by the provisions of this Act or who omits to do anything provided. required to be done under the provisions of this Act, or who in any way whatsoever violates or assists in or is party to the violation of any of the provisions of this Act shall be guilty of an offence and shall in all cases where no penalties are provided for such offence under the provisions of this Act be liable on summary conviction (and, in cases where

goods are by this Act made liable to forfeiture) beyond the forfeiture of such goods to a penalty not exceeding five thousand dollars.

Powers of boarding officer.

It shall be lawful for the Secretary, or any member of the Police Force or any person or persons deputed or appointed by the Secretary or acting under his direction to board any boat arriving, being at or departing from any place in the Island of Barbuda and to remain on board such boat until all the goods laden therein are duly delivered therefrom or until the departure of such boat from any such port or place, and such person or persons shall while on board such boat be allowed and have free access to every part of such boat and shall be at liberty thoroughly and efficiently to search the same and all lockers, boxes, and other receptacles whatsoever belonging thereto or to the master or crew or passengers thereof, and also all passengers' baggage and freight that may be in or upon such boat to whomsoever the same shall belong or be consigned, and shall be at liberty for the purposes of search to break open any locker, box, or receptacle, and the master of every such boat shall give and afford every facility for such search.

Penalty for obstructing, etc., a boarding officer. **52.** Any person who shall, when requested so to do by a boarding officer, refuse or neglect to open any closed locker, box or receptacle belonging to or in the possession of such peson. or who shall remove any goods whatsoever from any boat without the permission of a boarding officer or who shall refuse or neglect to give a boarding officer such information as to the ownership or contents of any receptacle on board a boat as may reasonably be demanded by such boarding officer, or who shall depart from any boat without the permission of a boarding officer, or who shall assault or beat, resist or wilfully obstruct any boarding officer while in the execution of his duty, shall be guilty of an offence under this Act and shall be liable on summary conviction to a penalty not exceeding three thousand dollars.
