**ANTIGUA AND BARBUDA CITIZENSHIP BY INVESTMENT (AMENDMENT)  
REGULATIONS 2020 MADE BY THE MINISTER IN EXERCISE OF THE POWERS  
CONFERRED UPON HIM BY SECTION 6 OF THE ANTIGUA AND BARBUDA  
CITIZENSHIP BY INVESTMENT ACT, 2013.**

**1. Short title**

These Regulations may be cited as the Antigua and Barbuda Citizenship by Investment (Amendment) Regulations 2020.

**2. Interpretation**

(1) In these regulations –

“principal Regulations” means the Antigua and Barbuda Citizenship by Investment Regulations 2016.

**3. Amendment of regulation 10 Ineligible Applicants**

Regulation 10 of the principal Regulations is amended by repealing paragraph (b) thereof and replacing it as follows –

“(b) having not received a free pardon, was at any time convicted of criminal offence and –

- (i) was sentenced to serve a period of imprisonment in excess of twelve (12) months; and
- (ii) the offence and conviction is such that had it occurred within Antigua and Barbuda, the applicant would be incapable of being regarded as a

rehabilitated person under the provisions of the Criminal records  
(Rehabilitation of Offenders) Act, 2013”
