**DECLARATION** dated **20<sup>th</sup> December, 2019**, made by the Secretary to the Cabinet pursuant to section 3 of the Land Acquisition Act Cap. 233 for the acquisition of the parcel of land located at Friars Hill Road in the Parish of St. John's and described in the Schedule hereto for a public purpose.

**IT IS HEREBY DECLARED** that the Cabinet at its meeting held on **Wednesday 10<sup>th</sup> July, 2019** considered that a portion of the parcel of land situate at Friars Hill Road in the Parish of St. John's and described in the Schedule hereto be acquired for a public purpose, namely, to facilitate the construction and expansion of the Public Highway more commonly known as Friars Hill Road.
