COMPANIES (AMENDMENT) REGULATIONS, 2020 made by the Minister in exercise of the powers contained in section 527 of the Companies Act 1995 No.13 of 1995.

1. Citation

These Regulations may be cited as the Companies (Amendment) Regulations, 2020.

2. Amendment to Regulation 27

Companies Regulations is amended by deleting regulation 27 and substituting the following –
